

Terms of Reference for JCoSS Teaching and Learning Committee of the Governors

There will be a minimum of six members on the Teaching & Learning Committee. The quorum for any one meeting shall be not less than three governors. Ex officio governors count towards the quorum (NB Associate members do not count towards the quorum) The Co-Chairs of Governors, Vice Chair of Governors & Headteacher, shall be ex-officio members of the committee.

The Committee will ensure at the start of every meeting that no members have a conflict of interest.

The Committee will elect a Chair from amongst the members of the Committee. In the absence of the Chair at any one meeting, the Committee will elect any member to act as Chair for that meeting. The Committee may invite non-governors to attend, in a non-voting capacity.

The remit of the Teaching & Learning Committee is to inform and make recommendations to the Governing Board on all matters relating to the standards achieved by the students and the curriculum of the school. Its role is to consider all matters relating to the academic standards achieved by the students and the format and effectiveness of the curriculum of the school. The Committee will then report and present these issues to the Governing Board.

In particular, the Teaching & Learning Committee has the following objectives:

- To advise the Governing Board on its statutory obligations regarding the curriculum
- In consultation with the Headteacher, to recommend to the Governing Board targets for student achievement
- To monitor the delivery of the curriculum and ensure that it meets the aims of the school and statutory requirements
- To monitor and evaluate results
- To monitor the religious character of the school
- To support the development and review of the curriculum in accordance with the aims of the school and statutory requirements
- To participate in internal school reviews, to receive the written reports and to monitor progress towards the implementation of the resulting recommendations including areas of development as identified by external reviews
- To monitor the School's Development Plan
- To approve, monitor and review all policies and procedures and documents which are assigned to the Committee
- To monitor and advise on questions of health and safety which arise from the delivery of the curriculum and on the coverage of health and safety issues in the curriculum
- To monitor and support consortium arrangements
- To monitor and support the development of ICT provision as it relates to the curriculum

The composition and terms of reference will be reviewed annually in the Summer Term
